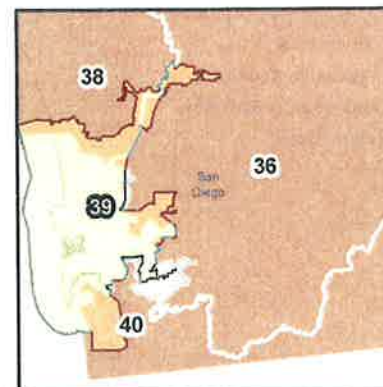
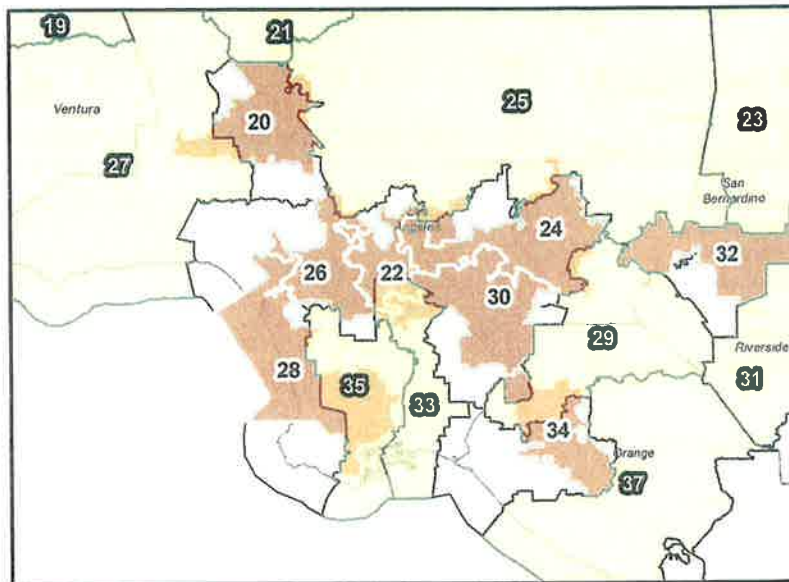

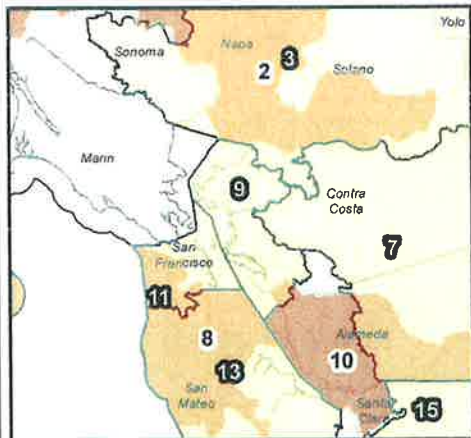
2013 - 2014 Senate Districts
