



Feather River College – Financial Aid Office 2017 Summer Aid Information

TO BE CONSIDERED FOR SUMMER FINANCIAL AID AT FRC YOU MUST

1. If you *are a continuing FRC student* who received aid for fall 2016 and/or spring 2017 semesters.
 - Register for all of your summer classes.
 - Attach a copy of your Student Detail Schedule for Summer 2017.
 - Submit the 2017 Summer Financial Aid Request form (available NOW)

NOTE: If you attended FRC during spring semester 2017, your summer aid **cannot** disburse until:

- i. ALL grades for ALL students are posted AND,
 - ii. The Financial Aid Satisfactory Academic Progress batch process has been completed.
2. If you *did not attend FRC* in the 2016-2017 academic year or you attended FRC but have not yet filled out the 2016-2017 FAFSA:
 - Complete and submit the 2016-2017 Free Application for Federal Student Aid (FAFSA) at www.fafsa.ed.gov listing FRC's school code (008597) [*if you attended a different school in 2016-2017 and received aid there, please add FRC's school code to your FAFSA*]
 - Follow through with the Financial Aid office to get your FAFSA processed quickly as well as completing any student requirements. Check your student portal ([MyFRC](#)) to see if you have any outstanding student requirements.
 - Register for all of your summer classes
 - Attach a copy of your Student Detail Schedule for Summer 2017.
 - Submit the 2017 Summer Financial Aid Request form

JUNE 30 DEADLINE:

If you have not yet filed the 2016-17 [FAFSA](#) or the 2016-17 BOG Fee Waiver Application, you MUST submit your 2016-17 FAFSA to the federal government before June 30, 2017 or 2016-17 Board of Governors Fee Waiver Application to FRC before June 30, 2017.

THESE ARE ABSOLUTE DEADLINES.

AID THAT IS AVAILABLE THIS SUMMER

- Board of Governors Fee Waiver (BOG) for eligible students
- Pell Grant if you have eligibility left from your 2016-2017 award
- Student Loans based on remaining eligibility (must be enrolled in 6 units for summer)
 - i. Must complete Summer Loan Application & Guidelines
- Parent PLUS Loans

TIMING OF SUMMER DISBURSEMENTS --

If you attended FRC during spring semester 2017, your summer aid **cannot** disburse until:

- ALL grades for ALL students are posted AND,
- The Financial Aid Satisfactory Academic Progress batch process has been run.
- Summer aid **will not** be disbursed to your student account until **you** begin classes.

If you would like to receive Financial Aid at Feather River College this summer, please complete the 2017 Summer Financial Aid Request form and return it to the Financial Aid Office along with a copy of your "Student Detail Schedule" which can be printed from MyFRC.
